Exhibitor set-up will begin Thursday, June 25th at 12:00 p.m. We ask that you be set up by 5:00 p.m. The hours the exhibit room will be open are **6:00 to 9:00 p.m. on Thursday, Friday a.m. and p.m. and Saturday a.m.** The trade show will close Saturday a.m.

Thursday evening from 6:00 to 9:00 p.m. will be Vendor Night. This night is set aside for you the vendor to showcase your equipment with attendees. This evening will also be complemented with hors d'oeuvres and will be BOYB.

Booth size is 10 ft. deep by 10 ft. wide and multiple spaces are available. Your booth space will include table and chairs, and full electricity.
